62nd ANNUAL REPORT 2023-24

On behalf of the Governing Council of Kerala State Branch of the National Association for the Blind, I have the pleasure to present before you the 62nd Annual Report for the year 2023-24.

Kerala State branch of the National Association for the Blind,(KSB-NAB) is a Non-Governmental Organization (NGO) registered under the Travancore Cochin Literary, Scientific and Charitable Societies Act XII of 1955, with Reg. No. 28/1972. This Association is the Kerala State Branch of the National Association for the Blind India (NAB India) functioning with Head Office at Mumbai. Initiated by the Late Benedict Mar Gregorios, the then Arch Bishop of Trivandrum, KSB-NAB started functioning from 20.12.1962. The Association has around 250 Life Members. Administration of the Association is carried out by the Governing Council, consisting of Senior Advisors, Executive Officers and other members, elected by the General Body and the tenure of the Governing Council once elected is for three years

KSB-NAB was formed with the intention of providing services to the visually challenged persons. Quite a large number of projects in different parts of Kerala have been undertaken by KSB-NAB for the benefit of disabled persons . Our focus is mainly on empowering those persons with disabilities, particularly the visually impaired persons and persons with multiple disabilities, by sensitization, training , education and providing opportunity for rehabilitation. So far KSB-NAB could rehabilitate more than 60,000 persons with disabilities. Our aim is to eliminate avoidable disabilities and promote equality of opportunity for the differently-abled by protecting their rights.

Programs and Projects

Some of the main programs and projects undertaken by NAB Kerala are given below briefly.

1. Vocational Training and Rehabilitation Program

One of the main aims of this program is to introduce the visually impaired persons into the main stream of society. We are running a Vocational Training Centre which gives training to the visually impaired and disabled persons in furniture re-caning, preparation of lotion and other cleaning materials, computer operation, envelop making, carry bags making etc. We also support them by arranging suitable job placements for deserving candidates.

2. Prevention of Blindness and other Disabilities

Camps were conducted in rural areas in different parts of the State to identify persons, particularly children, needing attention in respect of health care and providing required helps. During such camps special attention is given to create awareness among the people about hygienic life, nutritious food etc. so as to enable them to lead a better life preventing blindness and other disabilities to the extent possible.

3. Client Service Unit

There are different facilities provided by the Government for persons with disabilities including concession in travelling expenses, free medical care, reservation in jobs etc. There have been numerous cases of beneficiaries not being able to avail such facilities due to lack of awareness or for want of assistance to obtain the certificates required for availing them. KSB-NAB provides required assistance in such cases.

4. NAB LIC Group Insurance Scheme

Associating with LIC of India we are providing insurance coverage to selected number of visually challenged persons. During 2023-24 we have provided insurance coverage to 131 persons.

5. Care & Therapy Centre

Care & Therapy Centre is for taking care of children with disabilities including those with multiple disabilities, to a limited extent, giving physiotherapy and training in mobility, communication etc. and also imparting awareness to parents on care required for improving life of such children.

6. Computer Learning Centre for Visually Challenged

KSB-NAB Kerala has been imparting Computer Education to visually challenged with financial support from M/s IBS Software Pvt Ltd. This program is being continued.

7. Mobility Training Centre for training the Vision Impaired using White Cane

Our centre takes pride in offering personalized and comprehensive mobility training. Our expert instructors understand the unique needs of individuals with visual impairments and formulate programs to enhance their mobility skills. From mastering the proper techniques of white cane usage visually impaired can navigate various environments with confidence. Our curriculum is designed to empower each participant on their personal journey towards independence.

8. Special Service Project for Children in the Rural Area

KSB-NAB has been conducting camps in rural areas to identify persons with disabilities requiring support, particularly children belonging to BPL families and provide medical, therapeutic and financial support to the extent possible. The Rural Project started in Nemom Block Panchayat Area in 2019-20 was interrupted by the pandemic Covid-19 by March 2020. This could not be resumed due to financial constraints.

9. Music Troop

A music troop 'The Voice of NAB Kerala' had been formed earlier with talented singers among our Trainees and some training in music was given to them, with intention of developing it into a full-fledged professional troop. This program which was affected by the pandemic has since been not resumed.

10. Audio Recording and Publishing

The Audio Recording Studio functioning at KSB-NAB office enables preparation of text books and study materials in audio format for the use of visually challenged students. In this facility we prepare audio version of text books and study materials for various academic courses, entrance examinations and other competitive tests and published through Whatsapp and Telegram.

11. You Tube Channel 'DRISHYAM NAB'

KSB-NAB is maintaining the YouTube Channel 'DRISHYAM NAB' in which video & audio recordings covering various subjects like Current Affairs, Science & Technology News, Entertainment, Health & Lifestyle and Editorials in leading Dailies are being published daily. A digital weekly magazine containing the recordings of a week is collated and published on Google Drive. We are also maintaining the Face Book Account with posts on important activities of KSB-NAB.

12. Sound Recording & Editing Course

This course is intended to impart training in Sound Recording & Editing, so as to enable the Trainees to work in this field.

13. Projects taken up with IBS support

Life Skills Development Training for Visually Challenged Persons and Persons with Multiple Disabilities & Audio Recording Studio are major projects undertaken with financial support from M/s. IBS Software Solutions. 70 visually impaired persons attended the class during 2023-24

14. Mobile accessibility training

Mobile accessibility training for visually impaired individuals focuses on providing comprehensive education and support to enhance their ability to use smart phones and other mobile devices independently. This training is designed to address the

specific challenges faced by individuals with visual impairments, ensuring that they can navigate and utilize the features of mobile technology with ease and confidence. About 50 visually impaired persons were trained during the reporting year.

15. PSC Coaching Class

KSB-NAB provides PSC coaching classes to visually impaired students free of cost. About 15 persons attended the coaching class arranged for them.

16. Empower EDU Program

In a world that is increasingly driven by technology, access to computer education is crucial for unlocking opportunities and fostering independence. The visually impaired community faces unique challenges in acquiring these essential skills limiting their access to employment and social inclusion. Empower EDU, an ambitious initiative by us, is designed to break down these barriers and empower visually impaired individuals through a comprehensive six month job-oriented computer training program. The primary goal of the Empower EDU is to equip visually impaired individuals with the skill and knowledge necessary to thrive in the digital age. By focussing on computer literacy, mobility training, soft skills development and English language proficiency. The program aims to enhance employability and foster self-reliance among participants. This program commenced on 12/02/2024 and 8 visually impaired students took admission during the reporting period and is progressing successfully with the financial support of M/s IBS Software Pvt Ltd, Life Members and well-wishers.

17. Noon Meal Program

Another program implemented successfully by KSB-NAB with the sponsorship of life members is Noon Meal Program. This program started on 01/02/2024. By this program KSB- NAB provides noon meals to the visually impaired persons from outside as well as those visually impaired students of KSB-NAB.

Major Activities and Events in 2023-24

Meetings

1. Executive Council Meetings: During 2023-24 the Executive Committee met twelve times, on 20/04/2023,19/05/2023,09/06/2023,14/07/2023,11/08/2023,15/09/2023,11/10/2023, 17/11/2023,15/12/2023, 12/01/2024, 16/02/2024 and 15/03/2024.
2. Governing Council Meetings: During this period NAB conducted one Governing Council Meeting on 30/01/2024
3. General Body Meeting: General Body Meeting was held on 30/01/2024

Other Activities

1. Helen Keller day was celebrated on 28/06/2023. TA given to 43 visually impaired participants. Lunch was sponsored by M/s Zam Zam Restaurants, Tea & snacks by Er.J.Jayakumar, Photography by Mr.Gopalakrishnan Nair and Mr.K.S.Philip and mic system by Er.A.P.Jalajakumar. President Prof.John Kurian sponsored cash prizes to visually impaired students who got high marks in SSLC and winners in Braille writing & Reading competitions.
2. August 15,2023 : Advisor Mr.Josey Joseph hoisted flag along with Manchadivila Residence Association and YMC Trivandrum North.
3. Onam celebration was on 25/08/2024. Onam kits were distributed to 50 visually impaired persons and Rs 500 each given to 9 visually impaired persons in place of Onam kits . 112 participants were there for the Onam sadya. Life members and well-wishers donated liberally for celebrating Onam.
4. On 18th October 2023, we observed the White Cane Day. We conducted a rally with the participation of visually impaired persons, staff and trainees of NAB, Y's Men Club members , Life Members etc. 88 persons participated in the rally. President Prof. John Kurian and Vice president Mr.Gopalakrishnan Nair sponsored lunch for the participants. TA was given to the visually impaired participants.
5. As part of the eradication of blindness, NAB conducted an eye camp with the co-operation of Y's Men International SWIR, District-II and M/s Bejan Singh eye hospital, Nagercoil on 02/12/2023. During the camp 46 persons tested their eyes free of cost and found 16 of them needed cataract operation. M/s Bejan Singh eye hospital, Nagercoil conducted operation free of cost to those who were ready to reach their hospital.
6. World Disability Day and X'mas celebration of NAB held on 07/12/2023. 40 visually impaired persons attended the function. TA and lunch were arranged for the visually challenged persons who attended the programme. During the function M/s Inner wheel Club of Trivandrum Suburban distributed braille equipments to the visually impaired students. Lunch was sponsored by Mrs.Molly Stanly and Er.A.P.Jalajakumar.
7. Noon Meal Program of NAB started on 01/02/2024. Mr. Thomas George and Mr.Jose Zachariah sponsored the program for the months February 2024 and March 2024 respectively.
8. Inauguration of Empower EDU Program was done by His Highness Avittam Thirunal Adithya Varma at NAB Hall on 16/02/2024. The prizes sponsored by NAB for the Braille reading & writing competitions held on Louis Braille Day at Varkala Blind school were distributed on the same day Zam Zam Restaurants, Prof John

Kurian, Smt.Molly Stanly Mr.Pradeep.S ,Mr. Thomas Mathew, Smt.Rebeccamma Thomas,M/s Dr.Varkey Chacko& Leelamma Varkey Trust, Mr.K.K.Kunjachan etc are sponsors of this program.

Once funds are made available there should be a team consisting of competent and dedicated persons to implement programs, monitoring and reporting progress and utilization of funds to the Organizations who provide the funds.
